

Zusatz zur Einverständniserklärung:

According to § 4 a TestV (citizen testing) the following persons (groups) are entitled to free testing:

1.) Children up to and including 5 years of age 2.) Persons who cannot be vaccinated against the SARS-CoV-2 coronavirus at the time of testing due to a medical contraindication, in particular pregnancy in the first trimester of pregnancy, or who could not be vaccinated against the SARS-CoV-2 coronavirus in the three months prior to testing due to a medical contraindication 3.) Individuals who are participating in clinical trials of SARS-CoV-2 coronavirus vaccine efficacy at the time of testing or have participated in such trials in the three months prior to testing 4.) Individuals who are in seclusion due to confirmed SARS-CoV-2 coronavirus infection at the time of testing, if testing is required to end seclusion 5.) When required by the following named facilities or entities* or the Public Health Service to prevent the spread of SARS-CoV-2 coronavirus, asymptomatic persons are entitled to testing if they a) are currently being treated, cared for, maintained, or housed there, or b) wish to visit a person being treated, cared for, maintained, or housed there 6.) Persons who, on the day on which the testing takes place, a) will attend an indoor event or b) will have contact with a person who has either reached the age of 60 or is at high risk of severe COVID-19 due to a pre-existing condition or disability 7.) Benefit recipients who employ persons under a personal budget pursuant to Section 29 of the Ninth Book of the Social Code and persons who are employed by benefit recipients under a personal budget pursuant to Section 29 of the Ninth Book of the Social Code 8.) Beneficiaries who employ persons within the framework of a personal budget according to § 29 of the Ninth Book of the Social Code, as well as persons who are employed by beneficiaries within the framework of a personal budget according to § 29 of the Ninth Book of the Social Code 9.) Caregivers4 within the meaning of § 19 sentence 1 of the Eleventh Book of the Social Code 10.) Persons who live in the same household with a person infected with the coronavirus SARS-CoV-2.

The literal reproduction of § 4 a TestV can be found as a notice on the walls of this test center.

Since it is impossible for us to effectively check whether you are really entitled to a free test according to § 4 a TestV, we must ask you, in accordance with good order, to **affirm here in lieu of an oath (self-declaration)** that you are entitled to receive such a free test today. If you have any questions, our staff will be happy to assist you at any time. Do not hesitate to ask. We would like to point out that a false assurance could possibly constitute a statement offense according to § 156 of the German Criminal Code (StGB).
